Accredited with a trained staff in place, this veterinary clinic offers comprehensive care to companion animals. Accreditation is a long, rigorous process and difficult to achieve.

The staff is well-trained, with some in the industry for more than 25 years. Employees include 2 receptionists, a head nurse, an assistant nurse and groomer. Grooming is a newer addition, and has been offered for about eight months.

Looking beyond the exhibited symptoms, this practice completes a complete examination of patients to provide full spectrum care. Services provided include laser surgery, dentistry. orthopedic surgery, acupuncture, wellness, treatment of allergies, hormonal and digestive issues and rabies quarantine, which may be necessary to do on-site to bring animals into The practice sees 30 new patients per Hawaii. month on average, and provides existing clients with both emergent treatment and ongoing preventative care. There were 2,095 patients in 2017 with an average sale per patient of \$206.54.

The current owner is the DVM in the practice, and although planning to retire from the professions, is willing to stay on to transition for six months. Extended transition or part-time employment is negotiable.

The practice is located in a 2,000-square foot commercial condo, and includes a surgical suite, treatment rooms, 3 dog runs and reception area. Monthly lease payments are \$2,400/mo.

Growth opportunities include bringing after-hours emergency services in-house (currently use practice affiliates); expand client services to include exotic and pocket pets (the practice used to treat these types of animals, but has since moved solely to companion animals), expand inventory to include pet supplies and refine/improve the practice's website and SEO rankings.
